

## Frankfurt Declaration

### We demand that employers halt the sales pressure !

1. No sales targets for specific products
2. An end to excessive sales targets
3. More appreciation for employees' work and team work instead of constant supervision
4. More time and more staff mean better advice
5. Better and regular training courses for bank employees so that they can provide qualified advice
6. A reasonable fixed monthly salary – the salary should not depend on the sale of individual products

### We demand that European governments and the European Union Regulate and Supervise Financial Markets – And Stop Speculation !

7. The establishment of a strong national and European financial supervisory authority with responsibility for all who provide financial services
8. Stronger capital requirements for risky transactions
9. A ban on products which are essentially speculative in nature and a requirement that all securities trading is handled on public stock exchanges
10. All new financial products must be authorised by a supervisory body
11. The establishment of an independent, European public rating agency
12. The introduction of a financial transaction tax
